Once the scheduled timetable has been implemented, by the university the students must appear with their clinical uniform. Thepracticals will be conducted in the hospitals in various departments under the invigilation's of external and internal examiner. The pattern of practical exam starts with history collection format followed by procedure and bed side viva by both the examiners .Theexamination is completed with co-operation of hospital management, staff and patients .after completion of written exam in the hospitals,viva-voice will be conducted based on theory in order to fill the gap between theory and practical thus session will be conducted, followed by sending the practical answer sheets to the unive
