**GRIEVANCE COMMITTEE**


**Objectives:**

- To state a clear and fair process for students to raise a Grievance, and to identify the member of staff responsible for setting the Grievance.
- To realize the primary needs of the students and staff and secure civil liberties for everybody, a Grievance Redressal Cell has been constituted.
- The cell is indented to find solutions for problems like anti ragging, sexual harassment – any kind of physical or mental harassment, complaints regarding class room teaching – class room management, completion of syllabus, teaching methods etc, if and when they arise.
- The Grievance Redressal cell conducts meeting periodically and takes steps to redress the grievance.

**By –laws for Grievances Committee**

1. Sri Venkateswara College of nursing there shall be a Grievances Committee in this collage to deal with the grievances of students, teachers and other employees.
2. It shall be lawful for the Grievances Committee to entertain and consider grievances or complaints and report to Board of Management on such report shall be final.


